IV. SUPERINTENDENT'S REPORT

Revisions to the HIB Policy

Since revisions of the HIB policy were approved by the State on November 1, 2017, the Board of Education will need to adopt an updated policy prior to September, 2018. Strauss Esmay has provided Superintendent Smith with one that is compliant. The district's anti-bullying coordinators and specialists have received training on the revisions, which mostly involve minor language revisions. The most significant code revisions are: allowing an option for the Principal to make a preliminary determination if an incident is within the scope of N.J.S.A. 18A:37-14, the school district's ABS will investigate a HIB complaint regarding a district student attending an approved private school for students with disabilities, and the district's notification to all parents involved in a HIB incident must consider the actual or perceived protected category.

2018-2019 REVISED BUDGET

The school district received a revised State Aid notice from the State, informing the district that \$364,599.00 in state aid was being reduced from the school's 2018-2019 budget, at which time Mr. Corso then had to revise the budget and resubmit to the County office.
