The bid opening process will begin on the above date and time. No bids shall be received after the time designated in the advertisement. (N.J.S.A. 18A:18A-21(b)).

A prescribed Form of Questionnaire must accompany each school transportation bid.

Corporate bidders are required by law (Chapter 33, Laws of 1977 N.J.S.A. 52:25-24.2) to submit a list of names and addresses of all stockholders owning ten percent (10%) or more of their stock.

Bidders must also complete a “Statement of Assurance Regarding Non-Criminal Employment Check.”

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq., Affirmative Action Against Discrimination and N.J.A.C. 17:27 et. seq.

A Non-Collusion Affidavit and a contractor Questionnaire/Certification also must be filed with the bid. The bid package will also include other documents that must be completed and returned with the bid. Failure to comply with Instructions to Bidders and to complete and submit all required forms, may be cause for disqualification and rejection of the bid.

Successful bidder must have a successful corporate history and been in operation for a minimum of five years providing pupil transportation to districts of similar size.

Each bid shall be accompanied by a bid bond, cashier's or certified check for five percent (5%) of the annual amount of the contract, but not in excess of \$50,000.00.

All bids must be submitted on a bid form which will be furnished upon application at the Business Office of the Point Pleasant Borough Board of Education, and bids not submitted on such form may be rejected.

The Board of Education reserves the right to reject any or all bids pursuant to N.J.S.A. 18A:18A-2(s), (t), (x), (y).
